Exhibit Table Assignment: First Choice # \_\_\_\_\_ Second Choice # \_\_\_\_\_, BAHV will assign tables on a first-come, first-serve basis but reserves the right to change or reassign tables if a problem arises. Charges for the exhibit table(s) are listed on the attached floor plan for the show.

The charge for the selected exhibit table(s) is \$ \_\_\_\_\_. Non-members who join the BAHV by March 1<sup>st</sup>, 2012 will pay the member rate. Make checks payable to the BUILDERS ASSOCIATION OF THE HUDSON VALLEY, INC. Full rental fee is due on signing of this contract. No exhibit space is confirmed until payment has been received by the BAHV.

Set up time will begin at 12:00 p.m. Friday, March 30<sup>th</sup>. All exhibitors must be ready by 9:30 a.m. (March 31<sup>st</sup>) as no one will be permitted to set up thereafter. All exhibitors are expected to keep their booths up and staffed throughout the hours of the show. There will be a \$200 fine for any booth that breaks down prior to the official closing of the show at 4:00 p.m. All exhibits and materials must be removed from the premises by 8:00 p.m. Saturday evening, March 31<sup>st</sup>, 2012.

The exhibit charge includes one draped exhibit booth (10' wide x 8' deep unless otherwise noted), one draped table (see sizes below), two chairs, and an exhibitor name sign. Drapery colors for this year's show are **burgundy and white**. Electrical outlets are available for all exhibitors. No wires or extension cords will be permitted to cross over aisles. (Note: Exhibit Hall is not carpeted)

Exhibitors will be held responsible for any damages they cause to the premises, or injury, and they will not hold the BAHV responsible. Exhibitors are responsible for their own display materials, handouts, etc. The BAHV is not responsible for loss, damage or theft. The BAHV is in no way responsible for inclement weather and cannot guarantee the number of people who will attend the exhibit.

There will be absolutely NO REFUNDS after March 19, 2012, and no exhibitor will be admitted to the show unless the BAHV has received payment in full. However, the BAHV reserves the right to cancel the show and make full refunds on or before March 19, 2012.

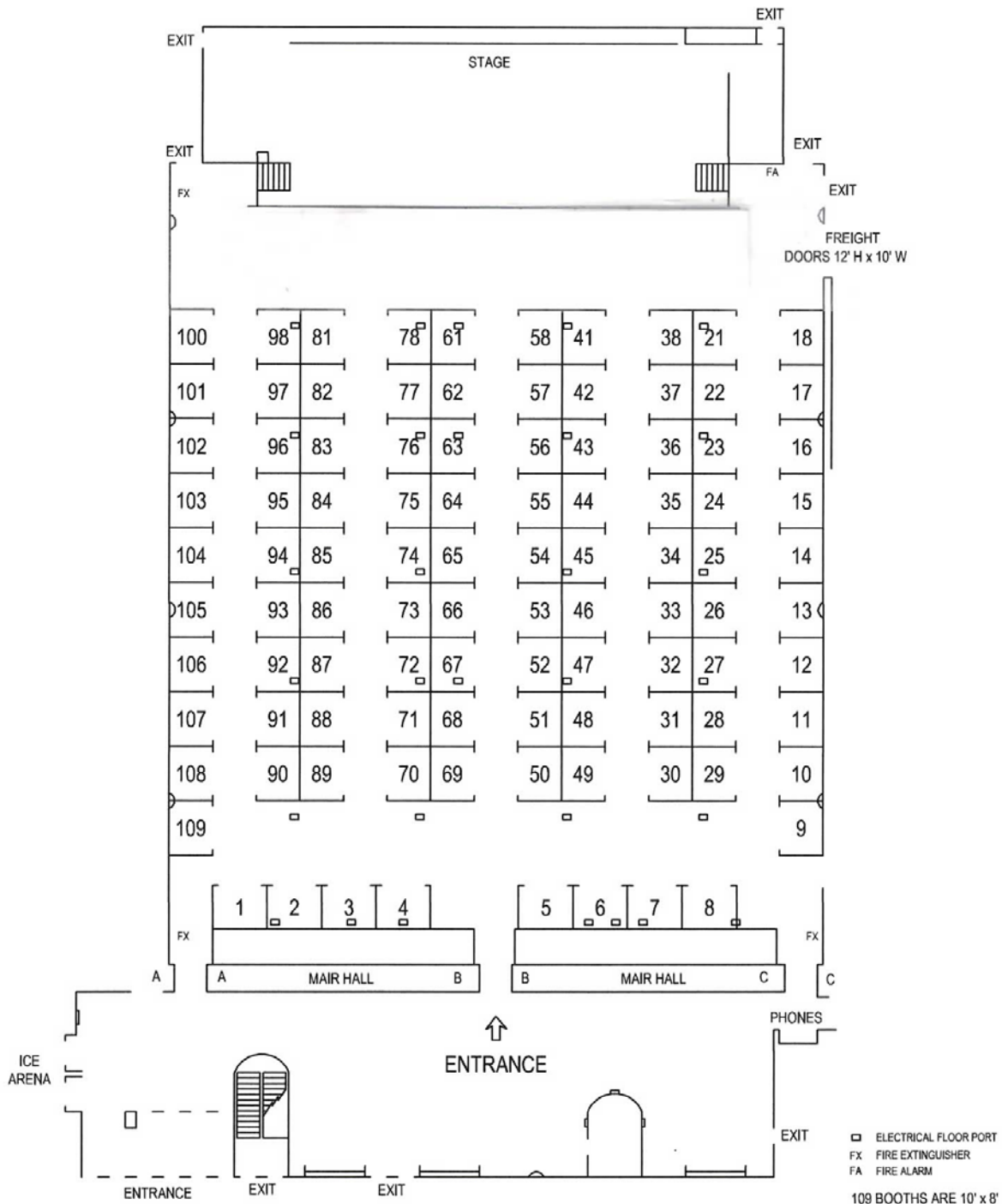

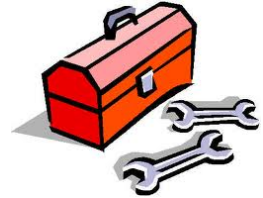
